1 Summary of Performance

1.A Introduction

This Budget Performance Report for Oyo State is prepared quarterly, and issued within 4 weeks from the end of each quarter

This report includes, the original approved budget appropriation for the year 2022 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q4, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations.

This Q4 report is assessed against the 2022 Approved Budget

The core economic classifications refer to:

- Personnel Economic Sub-Account Type 21
- Overheads Economic Account Class 2202
- Capital Economic Sub-Account Type 23 / 32
- Others Economic Account Classes 2203-2209 as applicable
- This Budget Performance Report is produced by the Accountant General Office, Ministry of Budget and Planning of Oyo State and published on the Oyo State website.

1.B Revenue Performance

The revenue at the end of the fourth quarter (Q4) ought to have performed at 100% but rather, it performed at 79%. The total revenue accrued to the State in the Fourth Quarter 2022 was \$\frac{1}{2}\$ 56,613,801,423.35 of the expected total revenue of the year 2022 Approved Budget. From total revenue, only the sum of \$\frac{1}{2}\$ 10,487,267,328.23 representing 18.52% was internally generated revenue (IGR) while Statutory Allocation, VAT & Others, was \$\frac{1}{2}\$46,126,534,095.12 representing (81.48%) and capital Receipts received during this period. This shows that the State still depends largely on External Sources for its Revenue though, there is a slight increase in IGR compared to the previous quarters of the year.

1.C Recurrent Expenditure Performance

Recurrent Expenditure by the end of the fourth quarter ought to have performed at 100% but rather, it performed at 89.3%. The total Expenditure expended in fourth quarter was the sum of #47,978,665,927.64, Recurrent Expenditure gulped the sum of #29,016,051,724.09. On recurrent Expenditure, Personnel Cost gulped #23,737,412,712.78 representing (81.81%), while Other recurrent Costs gulped #5,278,639,011.31 representing (18.19%)

1.D Capital Expenditure Performance

- ➤ Capital Expenditure at the end of the fourth quarter performed at ₩18,962,614,203.55 representing 39.52% of the total expenditure in the quarter under consideration. From the Capital Expenditure sum of ₩18,962,614,203.55, Economic Sector gulped ₩11,085,073,847.73, (57.22%), Social Sector ₩6,030,296,004.17 (31.08%), and General Administration gulped ₩1,623,861,789.91 (8.56%) while Law & Justice gulped ₩223,382,561.74 representing (1.17%)
- The **57.22**% of Capital Expenditure expended on Economic Sector was as result Government determination to provide infrastructure to ease the way of doing business that will bring about accelerated growth and development in the State. There was an increased in the Social Sector compared to the previous quarters.

1.E Conclusions

- The State 2022 Budget performance when compared with the previous years, shows there was an increase, in 2021, the State were able to achieved 59% performance of the Approved Budget while 79% was achieved this year, this simply showed that the measure taken by the State are yielding results
- ➤ It also shown that the State was prudent and realistic in her budget projection for year 2022
