1 Summary of Performance

1.A Introduction

This Budget Performance Report for Oyo State is prepared quarterly, and issued within 4 weeks from the end of each quarter

This report includes, the original approved budget appropriation for the year 2022 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q2, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations.

This Q2 report is assessed against the 2022 Approved Budget

The core economic classifications refer to:

- Personnel Economic Sub-Account Type 21
- Overheads Economic Account Class 2202
- Capital Economic Sub-Account Type 23 / 32
- Others Economic Account Classes 2203-2209 as applicable

This Budget Performance Report is produced by the Account General Department Ministry of Planning and Budget/ Oyo State equivalent, and published on the Oyo State website.

1.B Revenue Performance

The revenue at the end of the second quarter ought to have performed at 50% but rather it performed at 41.2%. The total revenue accrued to the State in the Second Qtr, 2022 was \$\frac{1}{8}\$ 61,360,459,359.59. of the expected total revenue of the year 2022 Approved Budget. From total revenue, only the sum of \$\frac{1}{8}\$ 9,750,273,024.68 representing \$15.88\% was internally generated revenue (IGR) while Statutory Allocation, VAT, Others, of the sum \$\frac{1}{8}\$51,610,186,334.91 representing (84.11%) and capital Receipts was received during this period. This shows that the State still depends largely on External Sources for its Revenue.

1.C Recurrent Expenditure Performance

By the end of the second quarter Expenditure ought to have performed at 50% but rather it performed at 37.6% of the total Expenditure of the sum of ₹53,934,804,832.96, Recurrent Expenditure gulped the sum of ₹32,679,081,307.91. On recurrent Expenditure, Personnel Cost gulped ₹21,894,032,401.46 representing (67%), while Other recurrent Costs gulped ₹10,785,048,906.45 representing (23%)

1.D Capital Expenditure Performance

- Capital Expenditure at the end of the second quarter performed at ₦ 21,255,723,525.05 representing 39.40% of the total expenditure in the quarter under consideration. From the On Capital Expenditure sum of ₦ 21,255,723,525.05 , Economic Sector gulped ₦ 19,566,580,492.81 , (92.04%), Social Sector ₦519,288,828.93, (2.50%), and General Administration gulped ₦1,169,854,203.41 (5,54%).
- The **92.04%** of Capital Expenditure expended on Economic Sector was as result Government determination to provide infrastructure to ease the way of doing business that will bring about growth and development in the State as priority while other areas will also be touch in the rest of the year.

1.E Conclusions

- The State is working assiduously to ensure that 75% Budget performance is achievable. Priority attention will continue to be given to projects that is going to have great impact on the State Economy also the State is putting measure in place to be self-reliant through enlarging the scope of the tax net and enactment of enabling laws that would boost revenue generation
- ➤ The State Fund Allocation Committee should be strengthening and made effective for efficient allocation of available fund to priority.
- ➤ The Budget Implementation Monitoring Committee will continue to carry out monthly review of budget performance with a view to ensure achievement of desired results
