1 Summary of Performance

1.A Introduction

This Budget Performance Report for Oyo State is prepared quarterly, and issued within 4 weeks from the end of each quarter

This report includes, the original approved budget appropriation for the year 2024 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q1, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations.

This Q1 report is assessed against the 2024 Approved Budget

The core economic classifications refer to:

- Personnel Economic Sub-Account Type 21
- Overheads Economic Account Class 2202
- Capital Economic Sub-Account Type 23 / 32
- Others Economic Account Classes 2203-2209 as applicable

This Budget Performance Report is produced by the Account General Department Ministry of Planning and Budget/ Oyo State equivalent and published on the Oyo State website.

1.B Revenue Performance

The 2024 Budget Revenue Components are made up of the following:

Government Share of FAAC (Statutory Revenue) - Out of the sum of N201,267,827,467.16

budgeted for the year, sum of **₩50,039,120,362.07** representing **24.90%** was realised during the First Quarter. The Statutory Allocation of **₩14,327,794,587.59** representing **16.00%** while VAT receipt was **₩24,987,559,909.69** representing **34.90%**.

Independent Revenue - The sum of **#92,793,620,681.33** was approved in the original budget, the total sum of **#13,172,976,889.97** representing **14.20%** was realised during the period under review. Revenue performance in the first quarter is relatively fair as assessment for taxation are normally undertaken up to the end of the quarter. This situation is expected to improve as payments are made after the assessment.

The aggregate revenue performance at the end of the first quarter stood at **N86,530,072,961.64** representing **19.70**% out of the **N432,447,878,548.39**. The Internal Generated Revenue of **X14,873,742,754.72** representing **17.19**% shows that the State still depends largely on External Sources for its Revenue, machineries has been put in place to drive the Internal Generated Revenue which the results will start manifesting by the next quarter.

1.C Recurrent Expenditure Performance

The State budgeted **₦213,538,475,738.94** for recurrent expenditure in 2024 with actual recurrent expenditure performance of **₦40,126,816,247.96** by the first quarter. The sum of

₩21,107,629,000.94 for Personnel Cost **representing 15.90%** while Overhead and Other Recurrent Cost gulped **₩19,019,187,247.02 representing 23.50%** performance.

1.D Capital Expenditure Performance

The State expended the sum of **№42,631,820,206.12** on Capital Expenditure representing **19.00%** of the total expenditure sum of **№42,631,820,206.12** in the first quarter. The sum of **41,069,369,133.03** which represent **39.50** % of actual capital expenditure expended on Economic Sector, **₩328,137,097.36** representing **2.70** % on Social Sector, **₩305,493,336.88** representing **0.40%** on Law & Justice while **₩296,137,198.03** representing **6.40%** was on General Administration, **₩960,820,538.18** representing **2.80%**.

The **39.50%** of Capital Expenditure spent on Economic Sector was because of Government determination to provide infrastructure to ease the way of doing business that will bring about growth and development in the State while other areas will also be prioritized in the last three quarters of the year.

1.E Conclusions

- The State is working assiduously to ensure that 75% Budget performance is achievable. Priority attention will continue to be given to projects that is going to have great impact on the State Economy. Also, the State is putting measure in place to be self-reliant through enlarging the scope of the tax net and enactment of enabling laws that would boost revenue generation.
- The State Fund Allocation Committee should be strengthening and made effective for efficient allocation of available fund to priority.
- The Budget Implementation Monitoring Committee will continue to carry out monthly review of budget performance with a view to ensuring achievement of desired results.
