A BILL FOR THE APPROPRIATION OF FOUR HUNDRED AND THIRTY- FOUR BILLION, TWO HUNDRED AND TWENTY- ONE MILLION, SEVEN HUNDRED AND SIXTY- FIVE THOUSAND, NINE HUNDRED AND THIRY- EIGHT NAIRA SEVENTY- NINE KOBO (N434,221,765,938.79) ONLY, BEING TWO HUNDRED AND ELEVEN BILLION, EIGHT HUNDRED AND EIGHTY- FOUR MILLION, FOUR HUNDRED AND FORTY- FIVE THOUSAND, SEVEN HUNDRED AND THIRTY- EIGHT NAIRA, NINETY- FOUR KOBO, (~~N~~211,884,445,738.94) FOR THE RECURRENT EXPENDITURE AND TWO HUNDRED AND TWENTY-TWO BILLION, THREE HUNDRED AND THIRTY- SEVEN MILLION, THREE HUNDRED AND TWENTY THOUSAND, ONE HUNDRED AND NINETY- NINE NAIRA, EIGHTY- FIVE KOBO (~~N~~222,337,320,199.85) ONLY FOR CAPITAL EXPENDITURE FOR THE SERVICES OF OYO STATE OF NIGERIA IN THE YEAR ENDING ON THE 31ST DAY OF DECEMBER, 2024

Date of Commencement: 1st of January, 2024

Enactment: Be the Bill enacted by the Legislature, Oyo State of Nigeria as follows:

(1) Short Title This Bill may be cited as the 2024 Appropriation Bill of Oyo State

(2) Appropriation of ~~(N~~211,884,445,738.94) Recurrent Expenditure 1st Schedule The sum of **Two Hundred and Eleven Billion, Eight Hundred and Eighty- Four Million, Four Hundred and Forty- Five Thousand, Seven Hundred and Thirty- Eight Naira Ninety- Four Kobo, (~~N~~211,884,445,738.94) Only** shall be appropriated from the Consolidated Revenue Fund during the year ending on the 31st day of December, 2024 for the services set out in the 1st schedule to this Law.
