1 Summary of Performance

1.A Introduction

The Budget Performance Report for Oyo State is prepared quarterly and issued within 4 weeks from the end of each quarter.

This report includes the original approved budget appropriation for the year 2024 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the third quarter, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations.

This Q3 report is assessed against the 2024 Original Approved Budget.

The core economic classifications refer to:

- Personnel Economic Sub-Account Type 21
- Overheads Economic Account Class 2202
- Capital Economic Sub-Account Type 23
- Others Economic Account Classes 2203-2209 as applicable

This Budget Performance Report is produced by the Accountant General Department/ Ministry of Finance/ Ministry of Budget & Economic Planning / Oyo State equivalent and published on the Oyo State website.

1.B Revenue Performance

The Recurrent Revenue in the Budget for 2024 is made up of Statutory share of government FAAC of **N201,267,827,467.16** and Internally Generated Revenue of **₩92,793,620,681.33**.

The total performance of Government Share of FAAC (Statutory Revenue) as at the end of third quarter is **₦233,296,480,793.12 representing 79.3%** of the original budget estimate while the internally generated revenue is **₦45,789,712,107.33 representing 49.3%** of the original budget estimate.

The performance of Aids and Grants **as** at the end of third quarter is **¥10,002,544,917.75 against 8,032,361,265.60** representing **124.5%**.

The aggregate revenue performance at the end of the third quarter stood at **\\$342,855,046,579.62** representing **78.2%** out of the **\\$438,447,878,548.39 budget estimate for the year**. Out of the aggregate revenue of **\\$327,388,946,506.31**, the Internal Generated Revenue was **\\$45,789,712,107.33** representing **49.3%**. This shows that the State still depends largely on External Sources for its Revenue. The machineries to mobilise for revenue in the state give a hope of improved revenue from fourth quarter.

1.C Recurrent Expenditure Performance

The State budgeted **₩213,538,475,738.94** for recurrent expenditure in 2024 with actual recurrent expenditure performance of **₩122,795,000,094.20** as at the end of third quarter. The sum of **₩71,554,709,572.31** was spent on Personnel Cost **representing 53.9%** while Overhead and Other Recurrent Cost gulped **₩51,240,290,521.89** representing **63.4%** performance.

1.D Capital Expenditure Performance

The State expended the sum of **H88,112,141,958.37 on** Capital Expenditure representing **39.4%** of the total capital estimate as at the end of third quarter.


The aggregate expenditure performance at the end of the third quarter stood at **№210,907,142,052.57 representing 48.1%** out of the **№438,447,878,548.39 estimated for the year**.


This performance is quite low than expected. This is as a result of due process for all capital releases. It is equally hoped that this will greatly improve by fourth quarter since some of these due processes would have been concluded.

1.E Conclusions

- The State is working assiduously to ensure not les than 75% Budget implementation is achievable by fourth quarter. Priority attention will continue to be given to projects that are going to have great impact on the State Economy. Also, the State is putting measure in place to be self-reliant through enlarging the scope of the tax net and enactment of enabling laws that would boost revenue generation.
- The State Fund Allocation Committee should be strengthening and made effective for efficient allocation of available fund to priority.
- The Budget Implementation Monitoring Committee will continue to carry out monthly review of budget performance with a view to ensuring achievement of desired results.
